### ELIGIBILITY:

All artists, at least 18 years of age, residing in U.S. are eligible. All original printmaking media are eligible which meet Artlink's exhibition criteria (available at [www.artlinkfw.com](http://www.artlinkfw.com)). No photography, computer generated or digitally altered prints will be accepted.

### JUROR and AWARD SELECTOR:

Ladislav Hanka earned an MFA in 1981; he has had close to 100 solo shows. Mr. Hanka's work is in about 100 public collections worldwide. The archive of his etchings, books, proofs & documentation is in Special Collections: Western Michigan University. Mr. Hanka draws and etches, working from observed experience, examining the fish and the frogs, trees & fungi in recurrent themes of life, death and transfiguration – nature as the crucible in which the artist finds a reflection of his own life and meaning. ### AWARDS:

Cash awards totaling \$2,500 will be presented. Winners will be listed in exhibition catalogue.

### ENTRY PROCEDURE:

Slides must be labeled to correspond with entry form. Print your name, title of work and designate the top of work on each slide. All electronic submissions must be emailed to [deb@artlinkfw.com](mailto:deb@artlinkfw.com). CD's will NOT be accepted. The ONLY accepted file format is JPEG via email submission not to exceed 1600 pixels in any direction, resolution of 150-300dpi or 3 megabytes per electronic file. Total email size should not exceed 50 megabytes and all files should be sent as attachments. Electronically rename the images with artist's last name and entry number which matches the entry form, e.g. Smith1.jpg. Mail the completed entry form with your check made payable to Artlink. Each artist is allowed three entries for \$25. Artlink members may submit three entries for \$20. The information listed on the entry form will be the information on the gallery labels. Email entries must be received on/before January 11, 2012. The mailed form and check must be postmarked January 11, 2012 or before. Any entries postmarked or received after January 11 will not be accepted.

### RETURN OF ENTRIES & DELIVERY OF WORK:

All slides will be returned January 14 -Feb. 10. All accepted work will be returned insured by UPS or FEDEX unless otherwise stipulated by the artist. All artists shipping work should include payment or pre-paid return shipment labels. Work should be sent in a reusable box. Prepaid shipping costs will be returned if the work is sold. Notify Artlink if your address changes. Please do not send wood crates or Styrofoam peanuts. All hand delivered entries must be picked up at the end of the exhibition. Work not claimed after 30 days becomes the property of Artlink, Inc.

**PRESENTATION:**

All work must be suitably framed and WIRED FOR HANGING. If you are shipping your work please use PLEXIGLASS rather than glass. Identification labels with artist name and title should be attached to back of work. No work should be sent unframed, with the exception of book art.

**SALES & REPRODUCTION:**

A 35% commission will be charged on works sold. If work is not for sale, circle NFS on entry card and give a value for insurance purposes. Artlink reserves the right to photographically reproduce accepted entries for publicity purposes. All pieces will be exhibited on Artlink website, [www.artlinkfw.com](http://www.artlinkfw.com).

**LIABILITY:**

The artwork will be insured while on exhibit. Artlink is not liable for damage or loss in transit.

**AGREEMENT:**

Artlink reserves the right to exclude from the exhibition any artwork that does not conform to the submitted slide or electronic submission. Sending entry constitutes agreement on the part of the entrant to all conditions stated above.
