



## Call for Portfolios: **Artlink Artist Members**

**Deadline – December 30, 2011**

Available exhibition dates in March 2012 - July 2013.

Current Artlink Artist Members are invited to submit 5 jpg images that represent a body of their work. This artwork will be considered for the Betty G. Fishman Gallery and is open to two dimensional work and some wall hanging 3 dimensional artwork. All artwork must align with Artlink's criteria regarding quality (criteria are available at [www.artlinkfw.com](http://www.artlinkfw.com)) and specifications as stated in this call for entry.

Artists are required to email an artist statement and a proposal for the gallery space. Please email the 5 images to [deb@artlinkfw.com](mailto:deb@artlinkfw.com) and include an inventory sheet which corresponds to the jpg images. Please include artist name, address, phone number, and email at the top of the inventory sheet. Please include the title, media and dimensions for each jpg image on the inventory sheet. CD's will not be accepted.

Artlink's Artist Panel will review the portfolio submissions in January and align the artwork with the works presented in the other Artlink Galleries. Artists will be notified of their acceptance and time slots January 16 – 31 so they may plan their calendars accordingly. We anticipate a large number of portfolios and will not be able to accommodate every members request. Each year the panel will review portfolios for the Betty G. Fishman Gallery which is reserved for Artlink members and educational partnerships. Every effort will be made to keep this a fair process to show as many members as possible while maintaining quality artwork.

All wall work must be matted and shrink wrapped or framed and wired for hanging. Saw-tooth hangers will not be accepted. All artwork must be hand-delivered to Artlink at an agreed upon date prior to the exhibition time slot during regular gallery hours. Artlink hours are Tues-Saturday 12-6 p.m., Thursday 12-8 p.m. & Sun 12-5 p.m. Giclee prints are accepted for electronic media only. All artwork must be identified on the back with your name and title. If your work is not for sale (NFS), please include the value for insurance purposes. If your work sells, Artlink will retain 35% of your sale price as commission. Artists will be asked to deliver an inventory sheet with their artwork. Artwork must remain in the gallery for the duration of the exhibit.

Artwork left at Artlink longer than 30 days becomes the property of Artlink, Inc.

Artwork created from a photograph must be a photograph taken by the artist or purchased rights from the photographer. This is the responsibility of the artist. Artlink reserves the right to not accept artwork that does not meet the above criteria or is deemed inappropriate for the exhibit.
